### **Food Vendor Vendor Rules and Regulations**

All food vendors must have current Cape May County Health Department certification, and a Fire Permit if required.

We reserve the right to restrict menus or refuse applicants on the basis of offerings.

Please plan to serve food and drink in environmentally responsible products: paper, foil, recyclable plastic products, etc. **NO STYROFOAM ALLOWED!**

Cost per Food Vendor space is \$50

#### **ALL APPLICATIONS MUST BE RECEIVED NO LATER THAN SEPTEMBER 7, 2019.**

1. All food vendors must have current Cape May County Health Department certification and any required licenses or permits. All food vendors must provide for proper removal and disposal of their wastewater, ice & cooking oil. There is no facility for liquid waste on site.
2. If you are cooking with an open flame, flame producing device or deep fryer, a fire permit issued by the state Division of Fire Safety is required. Apply and pay \$42 for a fire safety permit through RIMS Online. All permits shall be made available to the fire official upon inspection. Permits will not be issued unless payment is made in full. This is an application processing fee and is not refundable.
3. Spaces are assigned first come, first serve.
5. Set-up time begins at 8AM and must be complete by 9:30AM. Vendors may drive in to unload goods at their space. Vendors will be directed to a parking area. Food vendors must stay open until 3:00PM. **NO EARLY BREAKDOWNS!**
6. Vendors are required to have menu prices listed and visible to customers. Vendors must also have at least one fire extinguisher.
7. There is no electricity.
8. **NO** alcoholic beverages of any kind may be sold or given away by a vendor.
9. **NO** radios, televisions, musical equipment or any other audio or video equipment will be allowed.
10. This is a family event -- no loud or abusive language. DHHOA reserves the right to remove you from the festival without refund.
11. Tables should be covered on all sides to the ground and all boxes and storage totes must be out of sight. Please make your area as attractive and professional as possible.
12. The selling or giving away of balloons is prohibited because of environmental concerns.
13. This is a **RAIN OR SHINE** event. Plan ahead for the possibility of inclement weather.
14. There are no refunds or credits after September 28th.
